



# Note from our Director



In a year unlike any other, Monash Migration and Inclusion Centre re-directed all communication and engagement with key stakeholders, project partners, and the wider public online. Our online seminar and webinar events discussed and debated pressing issues relating to migration and social inclusion, recording strong levels of international and national engagement. We continued to foster academic and industry partnerships, provide learning and development opportunities, and secure funding to

respond to the challenges wrought by the pandemic. In this annual report, I am proud to share some of our achievements as we responded to the challenges of 2020.

Our Next Generation Network has grown considerably across the year, with approximately 200 post graduate students and early career researchers (ECRs) in our network, led by our Postdoctoral Fellow, Dr Charishma Ratnam. We held our first 'inclusion' hackathon in partnership with BehaviourWorks Australia and Wyndham City Council, providing an opportunity for our postgraduates and ECRs to work with industry partners in real world scenarios, to provide innovative solutions for organisations and the wider community. This was just one of many opportunities for mentorship, education, and engagement.

We are grateful for our continued partnerships within and outside academia. New projects have created opportunities to work with Monash colleagues from across the university. We have strengthened our academic relationships, notably through a Network of Excellence grant to examine migration to regional towns. We continue to foster opportunities for international collaboration through our membership in the IMISCOE network and an exchange fellowship program with Ryerson University in Canada.

Nationally, as well as our ongoing industry partnerships with Welcoming Cities, the Scanlon Foundation, and the International Education Association of Australia, our new partnership with Harmony Alliance led to the development of a national survey to understand issues that are important to women from migrant and refugee backgrounds, with a focus on safety and well-being. We look forward to sharing the results of the survey with you in early 2021.

As we begin 2021, we look back to all the learnings from 2020 and approach the new year with our shared goal of advancing migration and inclusion policy, practice and research.

The Monash Migration and Inclusion Centre (MMIC) is at the forefront of research, education, and public engagement concerning migration and social inclusion, and is committed to translating cutting-edge knowledge into practical solutions for policymakers, service providers, and communities. MMIC has built strong industry research partnerships with the Scanlon Foundation, Welcoming Cities, Wyndham City Council, Harmony Alliance, Department of Justice and Community Safety, Department of Premier and Cabinet, and the International Education Association of Australia.



# Celebrating partnerships

### Monash partnerships

The MMIC academic network harnesses the migration and inclusion research strength and expertise from across Monash University, working in partnership with academics from the Faculties of Arts, Education, Law, and Business and Economics. MMIC researchers collaborate on multidisciplinary research to understand and respond to contemporary migration and inclusion challenges through a number of projects.

In 2020, the Centre initiated a new research partnership to understand how organisations working with diverse communities used technology to maintain and sustain engagement with their community groups during the first COVID-19 lockdown. This research included a rapid review of existing research on the use of technology to facilitate and support intercultural engagement, and interviewing stakeholders who work directly with culturally and linguistically diverse (CALD) communities in Victoria. This has led to a transdisciplinary research partnership with research centres across the university, incorporating ActionLab, BehaviourWorks Australia, and the Monash Centre for Health Research and Implementation. Our co-designed approach puts bicultural workers and CALD young people at the centre of the project to build strategies for effective digital communication and engagement with community members. MMIC was recently awarded funding from the Department of Premier and Cabinet, Multicultural Coronavirus Response Taskforce to implement this research design targeting CALD young people.

In partnership with BehaviourWorks Australia and Wyndham City Council, we held our first 'inclusion' hackathon. This hackathon provided an opportunity for our postgraduate students and ECRs to take their research expertise in different directions and to new sectors. Our NextGen team worked with industry partners in real world scenarios, to provide innovative solutions for organisations and the wider community.

## Industry partnerships

MMIC has strong links with industry, with whom we collaborate to respond to pressing migration and inclusion challenges. Other national industry partnerships sustained through the year included:

- The development and implementation of the 'Migrant and refugee women in Australia' national online survey in collaboration with **Harmony Alliance**.
- Our evaluation of **Wyndham City Council**'s Social and Economic Inclusion Program and a Hackathon event focusing on the development of inclusive employment innovations for the Council.
- Our ongoing relationship with the **Scanlon Foundation**, including engagement with the Foundation's CEO, Anthea Hancocks, as MMIC Advisory Board Chair and cosupervisor of a Monash Diversity and Inclusion GRIP student.
- The assessment of the City of Greater Bendigo's cultural diversity and inclusion policy and practice against **Welcoming Cities**' Welcoming Standard. The standard is the benchmark for councils who wish to be accredited as a Welcoming City by an independent evaluation team at MMIC.
- MMIC Deputy Director Associate Professor Helen Forbes-Mewett continues to work in partnership with the International Education Association of Australia to address and respond to the safety, security, and well-being of international students.

### International partnerships

MMIC continues to develop and collaborate with international university partners, providing opportunities for collaborative research and for postgraduate learning and exchange.

As the first international partner outside of Europe, MMIC's membership of the International Migration, Integration and Social Cohesion (IMISCOE) network offers MMIC researchers the opportunity for international research partnerships, postgraduate connections and initiatives, and publishing platforms for migration and inclusion research.

The world-leading Border Crossing Observatory, led by core MMIC researcher Associate Professor Leanne Weber and our Centre Manager Rebecca Powell, continues its vital work on border crossings and irregular migration in partnership with colleagues at Oxford University and Oslo University.

# Learning opportunities for postgraduates and early career researchers

The MMIC NGN comprises postgraduates and ECRs whose scholarship broadly aligns with migration and social inclusion. The NGN members' interests and projects align with MMIC's research portfolios and contribute to innovative, applied research and valuable community engagement. Through the NGN, members share ideas across diverse disciplines such as sociology, law, health, criminology, geography, design, and politics.

The <u>NGN</u> is a platform for members to engage with other early career researchers, established scholars, policymakers, and industry practitioners. The NGN hosts events each year providing an opportunity for members to present their work and learn from senior academics and practitioners through masterclasses, workshops, and symposiums.

In 2020, the MMIC NGN welcomed Dr Charishma Ratnam, the Centre's first Postdoctoral Research Fellow as NGN coordinator. Dr Ratnam has worked with NGN members to expand the network and offer opportunities for learning and development. The NGN hosted three professional developments events throughout the year and offered new opportunities for students to work with industry on contemporary migration and inclusion challenges, including our first Hackathon.

**Associate Professor Rebecca Wickes** – Community resilience and cohesion, Rebecca's research focusses on demographic changes in urban communities and their influence on social cohesion and the concentration of social problems

**Associate Professor Helen Forbes-Mewett** – Identity and belonging, Helen's interdisciplinary work focuses on human security, migration, cultural diversity, international education and social cohesion.

**Associate Professor Marie Segrave** – Monitoring slavery and exploitation, Marie's current research is focused on temporary migration and labour exploitation in Australia, temporary migration and family violence and human trafficking and modern slavery

**Associate Professor Dharma Arunachalam** – Population movement, development, and the environment, Dharma's current research focuses on fertility and partnering, social cohesion, international migration, family and household structures, population research, ageing and health.

**Associate Professor Alan Gamlen** – Population movement, development, and the environment, Alan's research focuses on human migration and ethnicity, with special interests in the governance of international migration, diasporas, and transnationalism.




