



Re-enrolment Application Form

Who should use this form

Research degree and Monash Online students can use this form if you have not re-enrolled by the end of the late re-enrolment period. This means that you're no longer considered a current student and you need to apply to re-enrol.

Coursework students

Students studying coursework at Australian campuses need to use the online application, found on the <u>late or</u> failure to re-enrol web page.

Late re-enrolment fee

If your application for re-enrolment is approved, a late fee will be included on your fees statement and must be paid by the due date. See the current charge for the late re-enrolment fee on the miscellaneous fees page.

Supporting documents

You must provide supporting documentation outlining the exceptional circumstances that prevented you from reenrolling on time.

Notification of outcome

Your application will be assessed by your course managing faculty and you will be notified of the outcome by email to your Monash student account.

Re-enrolment

If your application is approved, you will be able to re-enrol through WES.

Deadlines

Apply as soon as possible – closing dates for applications for re-enrolment are determined by your faculty.

Submit your application by emailing us at mgro-candidature@monash.edu. Your application will be assessed by the Monash Graduate Research Office (MGRO), who will notify you of the outcome by emailing your Monash student account.
