#### SOCIAL MEDIA AS A FORCE MULTIPLIER: A STUDY OF MILITARY BEST PRACTICE

This project will review the literature examining the experiences of Israeli, US, British, Canadian, Dutch and Danish militaries as they adopted and deployed social media. The project will culminate in the production of a report that the Army can use to inform planning around the development of social media policy and its implementation within the organisation.

### AUSTRALIA-JAPAN COLLABORATIVE JAZZ ENSEMBLE
