

Application for Family (Sibling) Discount

- To be eligible, applicants must be enrolled in a full-fee degree or diploma course in the same semester as your sibling(s).
- If you or your sibling(s) have a Commonwealth Support Place (CSP), you are not eligible.
- The discount applies to course fees only and applications must be made every semester that you wish to receive the discount.
- The application must be received by Student Finance before 31 March to be applied to semester one fees and 31 August for semester two fees.
- You must provide the evidence of relationship (e.g. birth certificates). All photocopies must be certified by IDP, a solicitor or similar notable authority (e.g. Justice of the Peace) in either the students' home country or Australia and there is proof (i.e. letterhead, etc.) of the validity of the Solicitor/notable authority attached with the documents and translated.
- If you have applied previously, no further documentation is required. Please quote your **reference number**.
