

APPLYING TO MONASH NORTHERN TERRITORY STUDENTS

Applying to Monash University is different from applying through SATAC. This guide outlines how to apply for Monash courses and scholarships via VTAC, and includes key information on accommodation and NTCE score conversions.

What is VTAC?

VTAC (Victorian Tertiary Admissions Centre) processes applications for all Victorian universities. It's separate from SATAC, so offers from one won't affect the other.

Tip: Register at vtac.edu.au with an email you'll keep active all year.

VTAC key dates 2027 entry

- Applications open: early Aug
- Timely applications close: late Sept
- SEAS & Scholarships close: early Oct
- ATAR release & Change of Preference: early Dec
- Offer rounds: Dec 2026 - Feb 2027

Tip: Apply early. Some courses (e.g. Medicine) cannot be added after the **timely deadline**.

Apply for Equity Schemes (SEAS) & Scholarships

Special Entry Access Scheme (SEAS) adjusts your ATAR for challenges that affected your studies, giving you a fairer chance. One VTAC application covers both SEAS and scholarships.

NOTE: All schools in the Northern Territory are located in regional or remote areas (Personal Information and Location Category) based on the Australian Statistical Geography Standard- Remoteness Areas.

Equity schemes (SEAS) and scholarships categories

Personal Information and location

- Indigenous Australian
- born in a non-English-speaking country and moved to Australia after 1 January 2016
- live in a low socio-economic area
- attend a school in a regional or remote location
- first in family to attend university
- Aged 21 or older on 1 January 2026

Financial hardship

Living with a disability or medical condition

Difficult family and life circumstances

- experienced difficult personal circumstances
- being a refugee or asylum seeker.

Apply through VTAC. Check your eligibility monash.edu/entry-schemes.

The Monash Guarantee

The Monash Guarantee can help you gain entry into a Monash course even if your ATAR is below the usual selection rank. You may be eligible if you:

- have experienced financial disadvantage
- live in a low socio-economic area
- live or attend school in a regional or remote area
- are an Indigenous Australian
- are in Year 12 and attend a Monash-listed under-represented school.

How to apply

- submit a VTAC application with Monash courses in your preferences
- pay your VTAC application fee
- complete the equity schemes and scholarships (SEAS) application, and submit any required documentation

Prerequisites

You must meet all course entry requirements to be accepted into Monash. Entry requirements include prerequisite subjects such as English, and/or Mathematics and Science or extra selection requirements such as interviews and folios.

Some Monash courses will accept English-rich units if you did not undertake an English unit as part of NTCE.

Accommodation

Monash University Accommodation manages all student accommodation.

- Applications for 2027 open 1 September 2026.
- Applying is free, allocation is on a first-come, first-served basis, and there's no cancellation fee.

Monash Accommodation also provides off-campus advisory services. monash.edu/accommodation

Mannix College is opposite the Clayton campus, offering additional benefits to residents. Applications require a fee and an interview. mannix.monash.edu

Scholarships

When you apply through VTAC, Monash will consider you for the most suitable scholarships based on your circumstances. You'll be assessed for:

- Merit-based scholarships (based on your ATAR)
- Access and equity scholarships (via your Equity Schemes (SEAS) application. Requires supporting evidence.
