CURRENT PROJECTS MAKING A BIG DIFFERENCE

DigSmart: Digitalisation and urban waste management

In Indonesian cities, waste volumes routinely outstrip the infrastructure meant to handle them. Digitalisation is increasingly touted as the fix – but Monash Indonesia scholars Derry Wijaya (data science), Ika Idris (public policy) and Alex Lechner (sustainability) are asking harder questions about who actually benefits. Supported by the Danish International Development Agency (Danida) and in collaboration with the University of Copenhagen, Universitas Indonesia, BRIN and Zero Waste Alliance Indonesia, the DigSmart team is assessing the real costs and benefits of digitalised waste management, so working towards a green transition that is socially and environmentally just.

Indonesia's food estate: Feeding people without costing the earth

Indonesia Emas 2045 has a goal of complete food sovereignty – but large-scale food estate developments have raised serious concerns about biodiversity loss, carbon emissions and the displacement of farming communities. A multidisciplinary Monash Indonesia team – spanning data science (Taufiq Asyhari, Rizka Purwanto and Risqi Saputra), public policy (Sabina Puspita) and history (Luthfi Adam), supported by the Global Centre on Biodiversity for Climate (UK) – is developing open-access mapping tools to support evidence-based land use planning. The goal is a food system that works for people, communities and ecosystems alike.

Kita Bersama: Supporting Indonesian youth through adversity

In West Java and East Kalimantan, rates of depression among young people aged 15–24 are among the highest in Indonesia. Monash Indonesia researchers Grace Wangge and Gabriela Fernando (Public Health), funded by Grand Challenges Canada, are piloting Kita Bersama ("We Are Together") – a mobile app offering psychoeducation, anonymous peer support, emotional skills-building and pathways to professional care for underserved communities. The premise is simple: young people affected by violence deserve accessible support, not just a referral to services they cannot reach.

Banten Mosaic: Building habitat, health and prosperity

Banten Province sits adjacent to Jakarta yet remains in its shadow, grappling with sprawl, health disparities and deep economic inequality. Led by Stephen Cairns (Urban Design) and working with Monash University's Urban Transformation Network, UNTIRTA, BAPPEDA Banten, BAPPENAS, BRIN and local community organisations, Banten Mosaic develops credible, actionable models for sustainable urban growth – solutions designed for Banten's cities and regions, with lessons for rapidly urbanising societies everywhere.

Hate speech and democracy: Monitoring Indonesia's 2024 regional elections

Indonesia's 2024 electoral cycle was one of the largest democratic exercises in the world – but something troubling was playing out on social media. Monash Indonesia's Data and Democracy Hub researchers Derry Wijaya (Data Science) and Ika Idris (Public Policy) monitored nearly 480,000 posts across X and TikTok during the 2024 Regional Head Elections. Roughly one in ten contained hate speech, with the LGBTQ community most frequently targeted. The findings are a reminder that social media platforms have yet to meet their responsibilities in protecting vulnerable communities.

Gamified education on technology-facilitated violence

Funded by Monash's Research Talent Accelerator, Dr Dyah Pitaloka is pioneering immersive VR and interactive learning tools to build critical literacy around technology-facilitated violence. Designed for young people, women, educators, and parents, the project transforms complex digital harm issues into engaging, dialogue-driven experiences. Dyah collaborates with developers, designers, gamers, and community organisations to create tools that foster reflexivity and collective responsibility. The findings are clear: virtual harm carries real-world consequences, and education is the most powerful response.

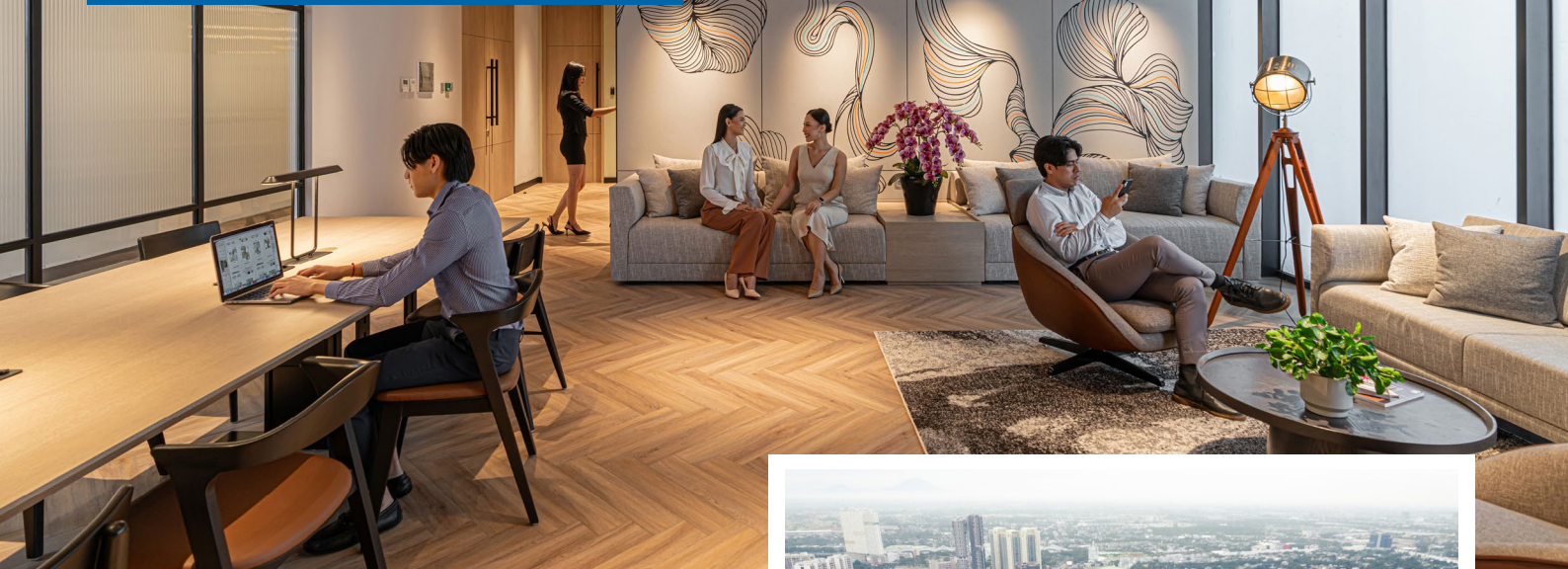
Our campus offers a unique blend of modern learning spaces, innovative research hubs, and a student-friendly environment in one of Indonesia's most dynamic townships.

LIVING IN JAKARTA — BSD CITY



At Monash University, Indonesia, you'll enjoy a safe, modern and globally-connected environment in BSD City, a thriving township that blends education, innovation and lifestyle.

STUDYING IN BSD CITY

BSD City is a modern, master-planned township in Tangerang, just outside Jakarta. It has everything you need within easy reach – cafes, restaurants, shopping malls, supermarkets, co-working spaces, parks and healthcare facilities. The campus is located in Green Office Park, a sustainable business district surrounded by greenery and lifestyle hubs.

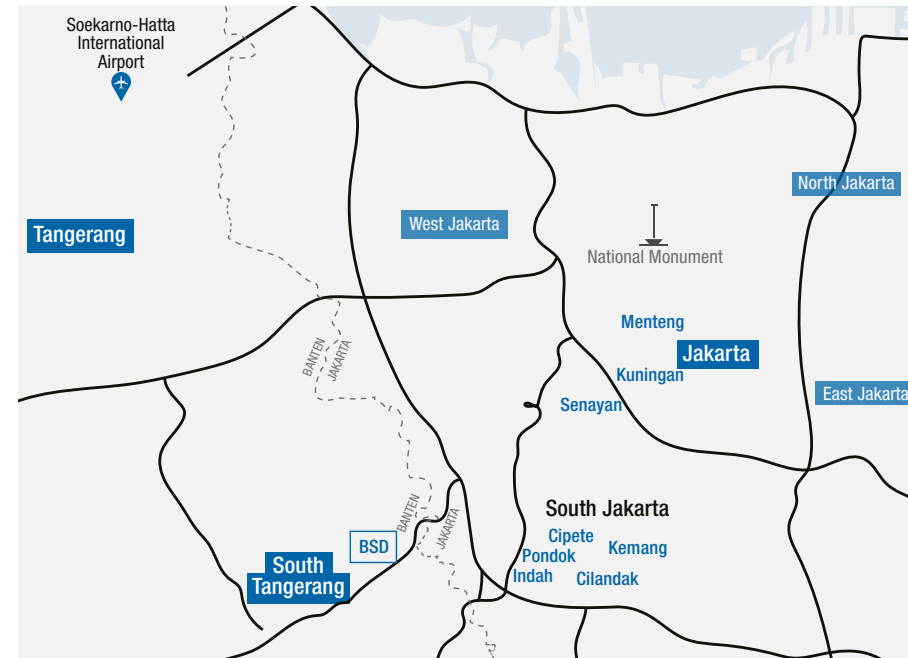
Jakarta's vibrant city centre is just 45 minutes away, where you'll find landmarks such as the National Monument (Monas), Kota Tua (Old Town), museums and regular cultural festivals. For weekend getaways, Banten's beaches and Bogor's cool mountain climate are just a short trip away.

COST OF LIVING (ESTIMATED IN IDR)

Before starting your studies, it's useful to plan a budget. Here are some indicative monthly expenses in BSD City/Jakarta:

- **Accommodation:** IDR 4,000,000 to 9,000,000 (boarding houses, serviced apartments, shared housing)
- **Phone and internet:** IDR 200,000 to 500,000
- **Groceries:** IDR 1,000,000 to 2,500,000
- **Eating out:** IDR 25,000 to 80,000 per meal (local warung to mid-range cafes)
- **Entertainment:** From IDR 50,000 per event (movies, concerts, exhibitions)
- **Transport (online taxis, buses, trains):** IDR 500,000 to 1,500,000.

Overall, BSD City offers an affordable lifestyle compared to other major global study destinations.



TRAVEL OPTIONS

Our campus in BSD City is well-connected:

- Soekarno-Hatta International Airport (CGK) – 45 minutes by car
- Commuter Line (KRL) – from Sudirman/Tanah Abang to Cisauk Station, connected directly to intermoda terminal by skybridge
- BSD shuttle and buses – regular services connect BSD with Jakarta city centre and nearby areas
- Online transport (Grab, Gojek, Maxim) – affordable and widely available for daily commuting.

WITHIN BSD CITY

Free shuttle services and eco-friendly buses operate between key BSD locations: AEON Mall, ICE Convention Centre, The Breeze lifestyle centre, BSD Junction and nearby residential complexes. Students can also walk or cycle safely on pedestrian-friendly pathways around Green Office Park.
