1. Diversity and Inclusion Week 2019

ADVANCING WOMEN'S RESEARCH SUCCESS GRANT

This program seeks to support the career progression of early to mid-career high potential academic women with primary carer responsibilities and assists the university in fostering talent to advance women to senior roles at Monash.

SENIOR WOMEN'S SHADOWING PROGRAM

The program aims to enhance the leadership capabilities of high potential women where participants can shadow their nominated senior executive for six half days, observing them in action.

WOMEN'S MENTORING PROGRAM

To support the development and career progression of female staff, this program facilitates mentoring partnerships and provide women with opportunities to reflect on and grow their leadership capabilities and build professional skills.

WOMEN IN STEMM ACADEMIC NETWORK
