Monash University is committed to providing staff, students, contractors and visitors with a healthy and safe environment.

Our goals are to prevent, or otherwise reduce, the risk of injuries, disease, and ill health that relate to Monash University activities.

The University promotes a proactive health and safety management philosophy based on effective communication and consultation, the systematic identification, assessment and control of hazards, and the encouragement of innovation.

- The University strives to fully integrate health and safety into all aspects of its activities through a process of continuous improvement. This will be achieved by: implementing and maintaining a framework that promotes the systematic management of health and safety, to ensure compliance with legal and other requirements; and
- Setting measurable objectives and targets aimed at controlling higher risk activities and increasing awareness of health and safety.

As an educational and research institution, Monash University recognises its responsibility to provide staff and students with positive role models and appropriate health and safety knowledge for application during and beyond their university life.
